

Coffee Transport Line Privacy Policy

Super Noah's Ark Trading Co., Ltd (the "Company", "we", "us", or "our")

respects your privacy and is committed to protecting it through this Privacy Policy. This policy describes the types of information we may collect from you when you use our game **Coffee Transport Line** (the "Game") and our practices for collecting, using, maintaining, protecting, and disclosing that information.

The Game is suitable for users aged 8 and above. If you are under 18, please review this policy with your parent or guardian. By using the Game, you agree to the practices described in this Privacy Policy.

1. Information We Collect

We collect minimal information necessary to provide you with the Game experience. Specifically, we collect:

1.1 Information You Provide Directly

- **Login Information:** When you log in to the Game using a third party platform (e.g., TikTok), we receive **only your public profile picture and nickname** from that platform. This information is obtained with your explicit authorization at the time of login.

- **No Other Personal Information:** We **do not** collect your real name, email address, phone number, home address, payment information, or any other personally identifiable information.

1.2 Information Collected Automatically

- **Game Progress Data:** We may store your in game progress (e.g., levels completed, scores) locally on your device or on our servers to allow you to continue your game across sessions. This data is associated with your profile picture and nickname but does not include any additional personal information.

- **Usage Data:** We may collect anonymous, aggregated statistics about how users interact with the Game (e.g., number of active users, average session

length, features used). This data cannot be used to identify you personally and is used solely to improve the Game.

2. How We Use Your Information

We use the information we collect for the following purposes:

- To create and maintain your in game profile (displaying your profile picture and nickname).
- To save and synchronize your game progress.
- To understand how users interact with the Game and to improve gameplay, features, and user experience.
- To respond to your inquiries or support requests (if you contact us directly).
- To ensure the security and integrity of the Game and to prevent fraud or abuse.

We **do not** use your information for profiling, advertising targeting, or any

commercial purposes beyond the operation of the Game.

3. Sharing Your Information

We do **not** sell, rent, trade, or otherwise share your personal information with third parties, except in the following limited circumstances:

- **With Your Consent:** We may share information if you have given us explicit consent to do so.
- **Service Providers:** We may engage trusted third party service providers (e.g., cloud hosting, analytics) who assist us in operating the Game. These providers are contractually obligated to protect your information and use it only for the services they perform for us.
- **Legal Compliance:** We may disclose information if required to do so by law or in response to valid legal requests (e.g., court orders, subpoenas).
- **Protection of Rights:** We may disclose information to enforce our Terms of Service, protect the safety of users, or defend against legal claims.

4. Children's Privacy

We take children's privacy seriously. The Game is designed to be suitable for users aged 8 and above. We do **not knowingly collect personal information from children under the age of 13 (or under the age of 16 in certain jurisdictions)** without verifiable parental consent. The only information we collect – profile picture and nickname – is considered minimal and is used solely for Game functionality.

If you are a parent or guardian and believe that your child has provided us with information beyond what is described, or if you would like to review or delete your child's information, please contact us at the email address provided below. We will take steps to remove such information promptly.

5. Data Security

We implement reasonable technical and organizational measures to protect your information from unauthorized access, use, alteration, or destruction.

However, no method of transmission over the Internet or electronic storage is 100% secure. While we strive to protect your information, we cannot

guarantee its absolute security.

6. Your Rights and Choices

Depending on your jurisdiction, you may have certain rights regarding your personal information, including:

- **Access:** You may request a copy of the information we hold about you.
- **Correction:** You may request that we correct inaccurate information.
- **Deletion:** You may request that we delete your information (note that this may affect your ability to use the Game).
- **Objection/Restriction:** You may object to or request restriction of our processing of your information.

We will respond in accordance with applicable law. Please note that we may need to verify your identity before processing your request.

7. Data Retention

We retain your information for as long as your account is active or as needed to provide you with the Game. If you stop using the Game or request deletion of your information, we will delete or anonymize your data within a reasonable period, unless we are required to retain it for legal, tax, or regulatory reasons.

8. Third Party Services

The Game may include links to third party platforms (e.g., TikTok) or services.

When you log in using a third party account, that platform's own privacy policy governs its collection and use of your information. We encourage you to review the privacy policies of any third party services you use.

9. International Data Transfers

Your information may be transferred to and processed in countries other than your own, including the United States (where the Company is based). These countries may have data protection laws that differ from those in your jurisdiction. By using the Game, you consent to the transfer of your

information to the United States and other countries where we or our service providers operate. We take steps to ensure that any such transfers comply with applicable data protection laws.

10. Changes to This Privacy Policy

We may update this Privacy Policy from time to time to reflect changes in our practices, legal requirements, or the Game's features. If we make material changes, we will notify you through the Game (e.g., a pop up notice or in game announcement) or by other means. The "Last Updated" date at the top of this policy indicates when it was last revised. Your continued use of the Game after any changes constitutes your acceptance of the revised policy.

11. Governing Law

This Privacy Policy shall be governed by and construed in accordance with the laws of the **State of Colorado**, without regard to its conflict of laws principles.

Any disputes arising under or in connection with this Privacy Policy shall be subject to the exclusive jurisdiction of the courts located in **Denver, Colorado**.
